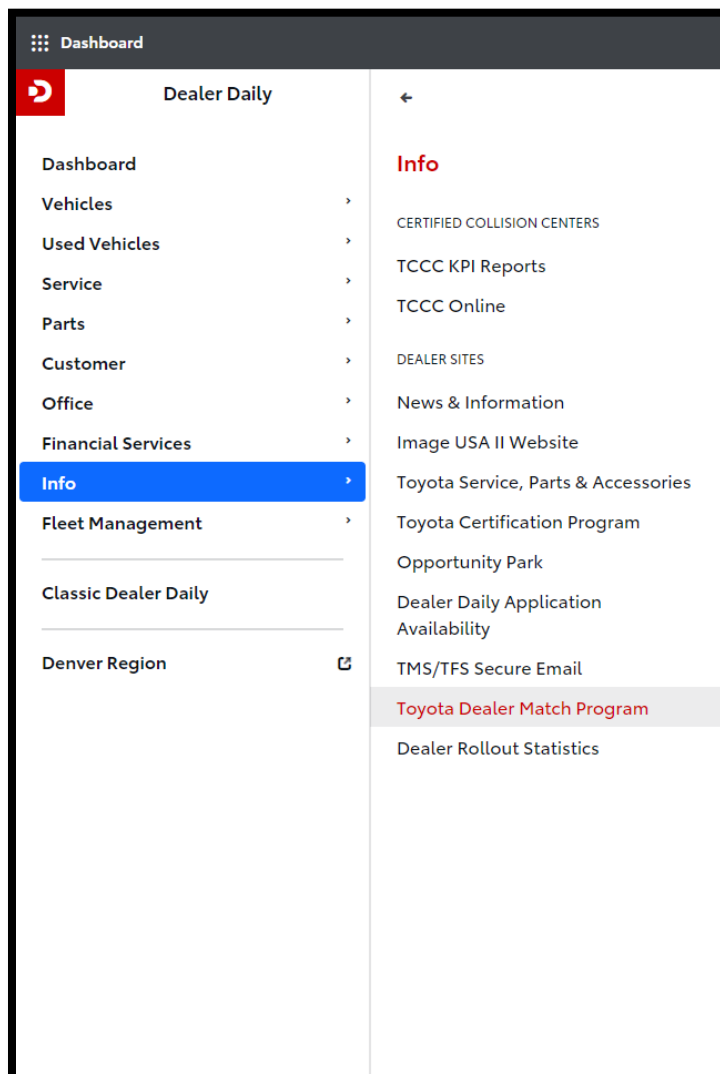




Dealer Match Instructions


